_____ Member agrees to abide by the USA Hockey Zero Tolerance Rule, even if the event is a non-USA Hockey sanctioned event, whether said member is an on-ice official, an off-ice official, a player, a coach or a spectator during the event.

_____ Member will sign all scoresheets **LEGIBLY** to provide proof that he/she has officiated said game.

_____ Member is responsible for finding his/her replacement in the event he/she cannot officiate a game for which he/she was scheduled to officiate. As a last resort, and in the event of a last minute emergency, member may call the NCHRA scheduler or a Board Member. Member is responsible for reporting a change in scheduled officials to the scheduler.
